Essay should be at least one full page and not more than two pages (may be double-spaced). The applicant should not mention his/her name or make any other identifying reference within the essay. Essay will be photocopied for the judges to read, so please be sure it is legible.
3. Submit high school transcript and Assessment scores, such as ACT or SAT, if applicable.
4. Applicant is required to have a letter of recommendation from a Catholic Daughter of Court Holy Cross #1598, Yorktown and submit with application.
5. Applicant is required to have Holy Cross presiding priest review and sign application before submitting application.
6. **APPLICATION, ESSAY, TRANSCRIPT, ASSESSMENT SCORES (SUCH AS ACT, SAT, ETC), AND LETTER OF RECOMMENDATION FROM A CATHOLIC DAUGHTER MUST BE SUBMITTED TO THE CDA EDUCATION CHAIRPERSON, AND RECEIVED BY MAY 5, 2024.**
7. The scholarship will be paid to each winner upon proof of higher education enrollment.
